ENFORCEMENT ON ENGINE OIL CERTIFICATION AND MARKING

The Ministry of Domestic Trade and Cost of Living (KPDN) has informed that there will be full enforcement on Trade Descriptions (Certification and Marking of Engine Oil for Motor Vehicle) Order 2024 beginning 7 October 2026.

Members are reminded that the new regulation has been in effect since last year, all engine oil products shall bear the SIRIM sticker in accordance to the Order; non-compliance may result in

- a. up to two hundred thousand ringgit (RM200,000) fine for company, and up to five hundred thousand ringgit (RM500,000) fine for a second offence or subsequent offence;
- b. up to one hundred thousand ringgit (RM100,000) fine and three-year imprisonment for individual, and up to two hundred and fifty thousand ringgit (RM250,000) fine and five-year imprisonment for a second offence or subsequent offence .

According to KPDN, more than three thousand inspections on premises selling engine oil products have been conducted since 7 October 2025, and more than one hundred warnings have been issued against products without the SIRIM sticker.

机油认证与标识执法

国内贸易及生活成本部（KPDN）告知，该部将从2026年10月7日开始针对《2024年贸易说明（机油认证与标识）指令》全面执法。

谨此提醒所有会员，该新条例已经在去年开始生效，所有机油产品必须依据“指令”贴上SIRIM贴纸，若违反条例，

- a. 公司可被罚款20万令吉（RM200,000），再犯可被罚款50万令吉（RM500,000）；
- b. 个人可被罚款10万令吉（RM100,000）和监禁3年。再犯可被罚款25万令吉（RM250,000）和监禁5年。

KPDN表示，自2025年10月7日起，已经针对售卖机油的场所进行超过3千次检查，并针对没有SIRIM贴纸的产品发出超过100个警告。
